from The Andrew Marr Show, interview with Justine Greening, MP, International Development Secretary, September 20, 2015

- 1 ANDREW MARR: Now the first people I read are coming next week from these Syrian
- 2 camps. Do you know how many people are coming and where they're going to go and how
- 3 they're going to be looked after?
- 4 **JUSTINE GREENING:** Well we don't have the exact numbers yet ...
- 5 **ANDREW MARR:** Rough numbers?
- 6 **JUSTINE GREENING:** ... in terms of how many people will be coming next week. We've set
- 7 up a taskforce that works across not just three government departments principally Home
- 8 office and Communities and Local Government, also DFID but also includes the Local
- 9 Government Association too.
- 10 ANDREW MARR: So ...
- JUSTINE GREENING: If I could just finish, Andrew. So that means that we are working in
- one team together. On top of that, the Prime Minister's also announced a new ministerial
- post Richard Harrington who will be leading this overall work to make sure that this
- resettlement process happens in a sensible way that means we get vulnerable people who
- want to resettle but also that we're working with local authorities and I'd like to thank those
- local authorities who've been working with us so hard to make sure that when they get
- 17 refugees into their communities, they're well prepared to manage that.
- 18 ANDREW MARR: So I asked you how many people were going to come in and you said you
- 19 couldn't give an exact number. Can you give me a very rough idea?
- 20 **JUSTINE GREENING:** I'm not ... I can't give you any ...
- 21 **ANDREW MARR:** You've no idea how many people are coming in next week?
- 22 **JUSTINE GREENING:** I'm not go... I'm not going to ...
- 23 **ANDREW MARR:** Isn't that rather extraordinary? I mean given ...
- 24 **JUSTINE GREENING:** Not really, Andrew.
- 25 **ANDREW MARR:** Well it's happening next week. I mean presumably arrangements have to
- be made to receive them and find homes for them, accommodate them, feed them, educate
- them if they're children and so forth. If you don't know how many people are coming in, how
- 28 are we going to do this?
- 29 **JUSTINE GREENING:** Well we are going to be bringing the first tranche of people over next
- week. I'm not going to on your show give you the precise numbers, but ...
- 31 **ANDREW MARR:** I didn't ask. Just a very rough idea was all I was asking for.
- 32 **JUSTINE GREENING:** I'm not ... I'm not going to give you the numbers, but we are well
- coordinated across government and also working with the Local Government Association.
- This will be the first group of people. We've said we'll take up to 20,000. I think the most
- important thing for us to work on has been to ensure that we are working with the UNHCR,
- but also working with local authorities here in the UK ...
- 37 **ANDREW MARR:** Alright.
- 38 **JUSTINE GREENING:** ... to do this proposal in a sensible way that will not only be help to
- the refugees we're trying to help, but also will be manageable for local authorities.
